Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to grant an order, direction or writ, more so in the nature of Mandamus.

(a)To declare the action of 2nd & 3rd Respondents in interfering into the peaceful possession and enjoyment of the land admeasuring Ac.4-02 Gts. in Survey No.17 of Khajaguda Village, Serlingampally Mandal, Ranga Reddy District, belonging to the Petitioner and other co-parceners, as arbitrary, illegal and in violation of Article 14 and 300A of Constitution of India and in violation of Sections 11, 13 and 54 of HMDA Act, 2008.

(b)To restrain the 2nd and 3rd Respondents from entering into the land and also changing the nature land i.e., land admeasuring Ac.4-02 Gts. forming part of Survey No.17 (Old Sy.No.117/3/16) of Khajaguda Village, Serlingampally Mandal, Ranga Reddy District, belonging to the Petitioner and other coparceners.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be

pleased to direct the 2nd and 3rd Respondents, its officials and staff from undertaking any works over the land admeasuring Ac.4-02 forming part of Survey No.17 (Old Sy.No.117/3/16) of Khajaguda Village, Serlingampally Mandal, Ranga Reddy District, belonging to the Petitioners and other coparceners, pending disposal of WP No 19997 of 2026, on the file of the High Court.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the 2nd and 3rd Respondents, its officials and staff not to interfere with the possession and enjoyment of the land admeasuring Ac.4-02 forming part of Survey No.17 (Old Sy.No.117/3/16) of Khajaguda Village, Serlingampally Mandal, Ranga Reddy District, belonging to the Petitioners and other coparceners, pending disposal of WP No 19997 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Srikanth Hariharan Advocate for the Petitioners, GP FOR MCPL ADMIN & URBAN DEV for the Respondent No.1, Sri V Narsimha Goud, for the respondent No.2 and Sri R Sameer Ahmed, standing Counsel for the respondent No.3, the Court made the following.

ORDER

Mr. R.Sameer Ahmed, learned Standing Counsel for HYDRRA, appearing for respondent No.3, seeks time to get instructions.

***Status quo* obtaining as on today shall be maintained in respect of the land admeasuring Acs.4-02 guntas in Survey No.17, Khajaguda Village, Serilingampally Mandal, Ranga Reddy District, till the next date of hearing.**

This order, however, shall not come in the way of respondents No.2 and 3 in taking action against the petitioners and in restoring the Thavutoni Kunta lake bearing I.D. No.3700/E/02, by issuing notice to the petitioners and by following due process of law.
