Yards of undivided land, situated in Plot Nos. 58, 58/1 and 921, known as Dr Pandit Rao Palnitkar's, Maitri Archade MG Road, Nallagutta Road, Secunderabad and with all other consequential benefits,

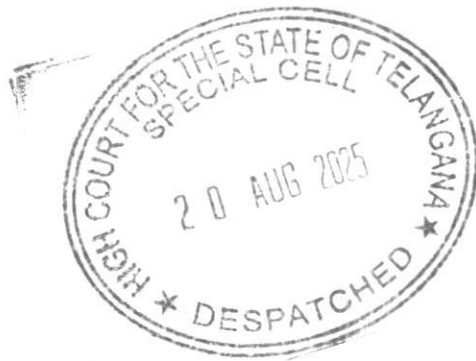
