Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to declare the action of Respondents in not issuing the hall tickets and not permitting us to appear before the Selection Committee for oral interview which is scheduled on 28.06.2026 at the office of the Respondent No2 (The Office of the Commissioner, Endowment Department, Boggulakunta, Hyderabad) as arbitrary illegal and against the principles of natural justice hence we pray the Hon'ble Court to direct the Respondents to issue hall tickets to the petitioners and permit the petitioners to appear for the oral interview which is scheduled on 28.06.2026 at the Office of the Respondent No2.

The petition coming on for hearing, upon perusing the Writ Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Vuthpala Sunil Kumar Advocate for the Petitioners, Government Pleader for Endowments for Respondent Nos.1 to 3 and Sri Ch. Satish Kumar, Standing Counsel for Sri Hemachala Laxmi Narasimha Swamy Temple for Respondent No.4 and the Court made the following.

ORDER

Heard Sri Vuthpala Sunil Kumar, learned counsel appearing on behalf of the petitioners, Sri Bukya Mangilal Naik, learned Government Pleader for Endowments appearing on behalf of the respondent Nos.1 to 3 and Sri Ch.Satish Kumar, learned standing counsel appearing on behalf of the respondent No.4-Temple.

Taking into consideration the specific plea put-forth by the petitioners that the petitioners satisfied all the eligibility criteria as laid down in the notification vide Rc.No.SHLNSD/15/2025, dated 22.11.2025 issued by the respondent No.4-Temple for the post of Paricharika at the 4th respondent Temple and duly considering the fact that the oral interview is scheduled to be held on 28.06.2026 at the office of the respondent No.2.

There shall be interim direction to the 2nd respondent i.e., the Commissioner, Endowment Department, Boggulakunta, Hyderabad to issue hall tickets to the petitioners and permit the petitioners to appear for the oral interview which is scheduled on 28.06.2026 at the office of the respondent No.2.

It is, however, observed that the result of the said interview pertaining to the petitioners herein shall not be declared pending further orders.

It is further observed that the order passed on this day of 25.06.2026 in favour of the petitioners herein is subject to the final outcome of the present Writ Petition No. 20067 of 2026.
