Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or orders one in the nature of WRIT OF MANDAMUS challenging the action of the Respondents herein more particularly Respondents No.4 and 6 in interfering with the peaceful possession and enjoyment of the Petitioner over the land admeasuring Ac.0.30 gts in Sy.No.450, Nagunoor Village, Karimnagar Mandal, Karimnagar District along with house bearing No.11-90/2 constructed thereon, covered vide Gift Deed dated 04.11.2006, despite pendency of A.S.No.308 of 2022 before this Hon'ble Court, as illegal, arbitrary, high-handed, without jurisdiction and violative of Articles 14, 21 and 300-A of the Constitution of India and to consequently direct the Respondent No.3 to conduct enquiry on the illegal interference of Respondent No.4 in respect of land in Sy.No.450 admeasuring Ac.0.30 gts., situated in Nagunoor Village, Karimnagar Mandal, Karimnagar District along with house bearing No.11-90/2 (constructed in the same premises) by considering Petitioner's representation dated 16.06.2026 in the interest of justice,

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent No.3 to forthwith conduct an enquiry into the illegal interference and high-handed acts of Respondent No.4 in respect of land in Sy.No.450, admeasuring Ac.0.30 gts, and house bearing No.11-90/2, Nagunoor Village, Karimnagar Mandal, by duly considering and acting upon the Petitioner's representation dated 16.06.2026, and to take appropriate action in accordance with law, Pending disposal of WP No 20720 of 2026, on the file of the High Court.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondents No.4 and 6 not to interfere with the Petitioner's peaceful possession and enjoyment of land in Sy.No.450, admeasuring Ac.0.30 gts, and house bearing No.11-90/2, Nagunoor Village, Karimnagar Mandal, Pending disposal of WP No 20720 of 2026, on the file of the High Court.
