Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction particularly one in the nature of Writ of Mandamus, declaring the action of Respondents in issuing Notice DR.No.A/595/2026 dt.18.06.2026 against the petitioners U/S 141 (1) (b) of BNSS Act, and Survey Notices to Survey the Petitioners land to an extent of Ac.0-12 gts in Survey No.25/e2/1, Ac.0-12 gts in Survey No.25/e1, and Ac.0-13 gts in Survey No.25/e3, total extent Ac.0-37 gts, though the Injunction Suit of Respondent No.6 and 7 vide O.S.No.139/2013 on the file of Prl.Junior Civil Judge, at Suryapet, dismissed on 26.12.2013, to harass the petitioners, as illegal, arbitrary and violative of Article 14, 19, 21 and 300-A of the Constitution of India, consequently SET ASIDE the Notice DR.No.A/595/2026 dt.18.06.2026 issued against the petitioners U/S 141 (1) (b) of BNSS Act, and Survey Notices to Survey the Petitioners land to an extent of Ac.0-12 gts in Survey No.25/e2/1, Ac.0-12 gts in Survey No.25/e1, and Ac.0-13 gts in Survey No.25/e3, total extent Ac.0-37 gts, in the interest of justice.
