No. 553 to an extent of Ac. 0-25 gts. and Sy. No. 554 to an extent of Ac. 0-25 gts., total admeasuring Ac. 4-37 gts. and agricultural land bearing Sy. No. 550 to an extent of Ac. 0-07 gts., Sy. No. 555 to an extent of Ac. 2-21 gts., Sy. No. 551 to an extent of Ac. 0-17 gts., Sy. No. 552 to an extent of Ac. 0-21 gts., Sy. No. 553 to an extent of Ac. 0-25 gts., Sy. No. 554 to an extent of Ac. 0-26 gts., total admeasuring Ac. 4-37 gts., grand total admeasuring Ac. 9-34 guntas., situated at Mankhal Village, Maheshwaram Mandal, Ranga Reddy District as being illegal, arbitrary, unconstitutional and contrary to the personal liberty contemplated under Article 226 of the Constitution of India, violative or principles of natural justice, misusing of official powers and violative of fundamental rights guaranteed under the Constitution of India

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri JANARDHAN REDDY KOTHA Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
