Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus declaring the Notice dated 24.05.2026 and 12.06.2026 issued by the Respondent No.3 directing the Petitioner Bank to hand over the pledged gold ornaments pertaining to Loan Account No. 4001329451 in connection with Crime No. 616 of 2026, dt. 01.05.2026, U/sec. 316(2), 318(4), r/w 3(5) BNS of Jawaharnagar Police Station, Malkajgiri Commissionerate, as illegal, arbitrary, without jurisdiction and violative of Articles 14 and 300-A of the Constitution of India, and consequently set aside the same.
