JUDGMENT: *(Per Hon'ble Sri Justice Abhinand Kumar Shavili)*

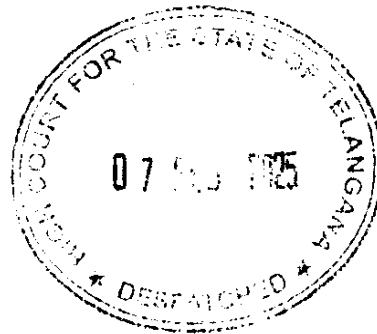
