AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI S.V. BHARADWAJA Advocate for the Petitioner and GP FOR HOME for the Respondents No. 1 to 3 directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.
