WHEREAS the Petitioner above named through her Advocate SRI SIMHADRI VENKATA BHARADWAJA, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus declaring the action of the 3rd Respondent in issuing the impugned freeze communications dated 11.09.2025 to Respondents 4 and 5 and the consequent freezing of the bank

accounts of the petitioner vide accounts at Indian Bank, Srinagar Colony Branch, Hyderabad - Cash Credit (CC) facility with a sanctioned limit of Rs.8,50,00,000/- A/c.No.8103497712, and Indian Overseas Bank, West Marredpally Branch, Secunderabad - Account No.103302000001238, as illegal, arbitrary, without jurisdiction and void, and to quash the same and consequently direct the Respondents 4 and 5 to forthwith de-freeze and permit the normal operation of the said accounts, and to restrain the Respondents from interdicting the operation of the said accounts except in accordance with law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI SIMHADRI VENKATA BHARADWAJA, Advocate for the Petitioner and GP FOR HOME, for the respondent Nos.1 to 3, directed issue of notice to the Respondent No.4 & 5, herein to show cause as to why this WRIT PETITION should not be admitted.

Learned Government Pleader for Home takes notice on behalf of respondents No.1 to 3 and waives further notice.

Registry is directed not to take out notice to respondents No.1 to 3 in view of the above waiver.

Issue notice to respondents No.4 and 5.

Learned counsel for the petitioner is permitted to take out personal notice on respondent Nos.4 and 5 by SPAD and file proof of the same in the Registry.
