AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Ms MUKKERA SAHITHI SRI KAVYA Advocate for the Petitioner and Mr. P Sri Harsha Reddy, standing Counsel for the respondent Nos. 1 to 6, directed issue of notice to the Respondent No.7, herein to show cause as to why this WRIT PETITION should not be admitted.
