Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents, more particularly the Respondent Cantonment Board in interfering with the Petitioners running business in the name and style of M/s. Jayaram Liquors situated in Plot No.2, Shop No.1, 2 and 3, Brig. Syed Road, Panchavathi Colony, Bowenpally, Secunderabad, TS, by issuing the Impugned Notice vide Lr.No.SCB/RS/Trade License/2026/1193 dt.29/06/2026 , insisting the Petitioner to submit an application for grant/renewal of Trade License along with prescribed document and fees to the Respondent Cantonment Board,

despite of Petitioner making a specific application vide Application No.SECU/2026/1252068/TL-APP dt.18/05/2026, for issuance of Trade License, as illegal, arbitrary, unconstitutional and in violation of Articles 14, 19 and of the Constitution of India and Consequently direct the Respondent Cantonment Board not to interfere with the Petitioners running business in the name and style of M/s.Jayaram Liquors situated in Plot No.2, Shop No.1, 2 and 3, Brig.Syed Road, Panchavathi Colony, Bowenpally,Secunderabad, TS, by considering the Petitioner's Application No.SECU/2026/1252068/TL-APP dt.18/05/2026 and by collecting the requisite Trade License fee as prescribed under the provisions of The Cantonments Act, 2006.

Heard Mr. C.H.Jayakrishna, learned counsel for the petitioner;
Mr. K.R.Koteswar Rao, learned Standing Counsel for Secunderabad
Cantonment Board (SCB), appearing for respondents No.1 and 2; Mr. P.Vishal
Kumar, learned Assistant Government Pleader for Prohibition and Excise,
appearing for respondents No.3 and 4; and perused the material on record.

2. According to the learned Standing Counsel for SCB, the trade licence
application submitted by the petitioner on 18.05.2026 has been rejected as
evident from the copy of the online information which is placed on record.
However, under the impugned notice dated 29.06.2026, the petitioner was
directed to submit application for grant/renewal of the trade licence. If such
application is submitted, the same will be considered in accordance with law.

4. In the circumstances, this writ petition is disposed of directing the petitioner to submit application for grant/renewal of his trade licence as directed under the impugned notice dated 29.06.2026, within a period of two (2) days from today. Until such application is considered and orders are passed, the respondent authorities not to interfere with the business of the petitioner run under the name and style of 'Jayaram Liquors'. There shall be no order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition, stand closed.
