Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or direction or writ in the nature of Mandamus duly declaring the impugned notice vide C.No. 170/CSB-KMM/2026, dated 27.06.2026 withdrawing the personal security arrangement to the petitioner without any enquiry or prior intimation as illegal arbitrary and against the principles of natural justice and consequently set aside the same and direct the respondents to reinstate provide the security cover of 1+1 PSO's (Personal Security Officer) and also to provide any additional security, forthwith to the petitioner in the interest of justice.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the impugned notice vide C.No. 170/CSB-KMM/2026, dated 27.06.2026 and direct the respondents to reinstate the security cover of 1+1 PSO's (Personal Security Officer) forthwith to the petitioner in the interest of justice, pending disposal of WP No 20775 of 2026, on the file of the High Court.
