Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of writ of mandamus declaring the action of the respondents in interfering into the peaceful possession and enjoyment of the house bearing No 3-1-Raooo9 extent 486.66 sq. yards situated at Ramnagar, Budhakalan, Bellampally Municipality, Mancheria district and trying to demolish the same even application filed for regularization. vide

No. 76APLMCL23060009146 dated 26.6.2023 is pending with the instigation of respondent No. 7 without issuing any notice and following due process of law as arbitrary and illegal and in violation of the fundamental rights guaranteed under article 14, 16, and 300A of Constitution of India consequently direct the respondents No. 2, 4 to 7 not to interfere into the peaceful possession and enjoyment of the subject property of the petitioner without following due process of law.

ORDER : (ORAL)

Heard Mr. Gudi Madhusudhan Reddy, learned counsel for the petitioner, Mr. Putta Krishna Reddy, learned standing counsel for respondent No.2, Mr. M. Sahas Reddy, learned Assistant Government Pleader for Revenue, appearing for respondent Nos.3 to 5, and Ms. P. Tejaswini Rathod, learned counsel, representing Mr. P. Sri Harsha Reddy, learned standing counsel for Singareni Collieries Company Limited (SCCL), appearing for respondent No.6.

2. Learned standing counsel for SCCL- respondent No.6 placed on record written instructions and submitted that there is no interference by respondent No.6 with the possession of the petitioner over the subject property as alleged in this writ petition.

3. Learned standing counsel for respondent No.2 and learned Assistant Government Pleader for Revenue also submitted that there is no interference with the possession of the petitioner over the subject property.

4. Learned counsel for the petitioner submitted that in similar circumstances this Court disposed of W.P. No.34957 of 2025 by order dated 19.11.2025 and prayed to grant similar relief in favour of petitioner herein.

5. In view of the above, without entering into the merits of the case, the writ petition is disposed of, directing respondent authorities not to interfere with the peaceful possession and enjoyment of the petitioner over the property bearing H.No.3-1-Ra0009 admeasuring 486.66 square yards situated at Ramnagar,

Budhakalan, Bellampally Municipality, Mancherial District, without following due process of law. However, respondent authorities are at liberty to take action against the petitioner, by issuing prior notice to the petitioner, by affording opportunity of hearing to him, in accordance with law. There shall be no order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition stand closed.
