This petition coming on for hearing, upon perusing the petition and affidavit filed in support thereof and upon hearing the grounds, the Court made the following: **ORDER**

Learned counsel for the respondents stated that they were specifically directed by the Co-ordinate Bench on 28.06.2022 to issue necessary instructions to the concerned for release of the aided salary to the writ petitioner with effect from 01.04.1992 from which he was absorbed as an aided S.G.T in the respondent No.5 School. He further stated that as their Officer did not comply the same their appearance was ordered and gave undertaking to pay the amount.

A perusal of the docket order dated 08-12-2023 shows that the District Educational Office, Peddapalli appeared and submitted that they have addressed a letter to the concerned authorities for released of budget. As soon as the budget is released by the concerned authorities, they will comply the orders passed by this Court. But later they filed their review application after one year and they stated that the respondent No.1/writ petitioner never worked and created bogus record including bogus training certificates and these grounds ought to have raised during the pendency of the writ petition but not under review. When once, they have given undertaking to pay the amount, now they again raised objection against the order of the writ petition on the ground that it is error on the face of the record. The scopy of the review is limited. Moreover, they filed review and they did not appear and failed to prolong the litigation. Therefore, it is clear that review is filed to pursue the litigation and accordingly this review application is dismissed.

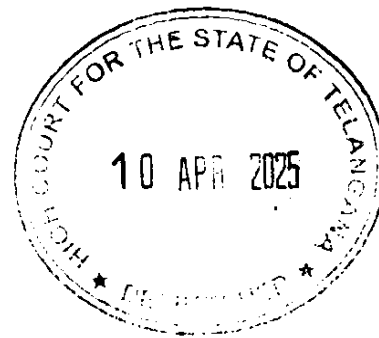
