This application is filed to recall the order dated 07.02.2025 in I.A.No.2 of 2024 in Writ petition No.32703 of 2012.

Heard learned counsel for the appellants.

Mr. Rahul Reddy, learned Special Government Pleader from the Office of learned Additional Advocate General submits that on 07.02.2025, review petition vide I.A.No.2 of 2024 is dismissed not on the basis of facts but due to non appearance of counsel of Review Petitioners. It is further submitted that the issue involves payment of huge amount from the public exchequer to the writ petitioner who secured appointment based on fake certificate and also submits that a detailed counter was filed in the review petition. It is further submitted that based on the orders in W.P.No.24091 of 2004 dated 25.04.2005 and facts of both the case are not similar.

Considering the reasons stated in the accompanying affidavit and submissions made by learned Special Government Pleader from the Office of learned Additional Advocate General, this application is allowed.

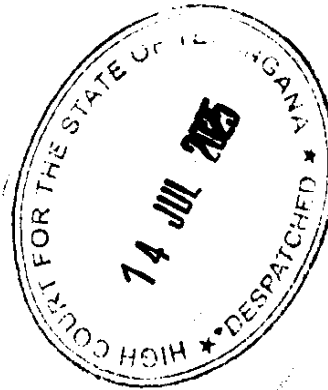
