WHEREAS the Petitioner above named through his Advocate M/S M M ALI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction particularly one in the nature of Writ of Mandamus declaring the actions of respondents in not considering the claim of the petitioner for promotion as Revenue Officer / Manager, without reference to long pending disciplinary proceedings vide GO -Rt 478, M.A and UD (Vig. 42)) Dept., Dt 21/06/2018, as illegal, arbitrary, unconstitutional, contrary to law and consequently direct the respondents to consider the claim of the petitioner by promoting him as Revenue Officer / Manager, from the post of Senior Asst on par with the Junior Officers who were already promoted,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/S M M ALI Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
