Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction, more particularly one in the nature of a Writ of Mandamus declaring the action of the respondents Nos. 4 and 5 as illegal, arbitrary, a dereliction of duty according to established principles of law, and consequently direct the respondents Nos. 4 and 5 not to interfere in the civil disputes between the petitioner and respondent No. 6, and also to grant police protection to petitioner who is a senior citizen aged 76 years.
