Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an Order, Direction or Writ more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No.5 in passing the refusal order vide No 59/2025 dated 04.07.2025 in furtherance of the letter No. vide Lr. No. JC-1/Peshi/Spl/2009 dated 20-02-2009 for all that piece and parcel of the undivided and unspecified notional half share in Plot no. 187/A (South Part), admeasuring 150 Sq.yds, or its equivalent 125.41 Sq.mtrs (out of 500 Sq.yds) in Survey No.200 Situated at "Sreepuram Colony" in Saheb Nagar Kalan Village, Hayathnagar Revenue Mandal, Ranga Reddy District, under Ward No.5, Block No.8 of GHMC Limits, Hayathnagar Circle, under registration Sub-District Vanasthalipuram in the prohibitory list U / s 22 (A) of Registration Act, arbitrary, illegal and consequently direct the Respondent No 5 to register and release the sale deed vide Pending Document No. P140/2025 dated 25.06.2025 without reference to letter No. vide Lr. No. JC-1/Peshi/Spl/2009 dated 20-02-2009.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.5 to register and release the sale deed vide pending document No. P140/2025 dated 25.06.2025 in respect of all that piece and parcel of the undivided and unspecified notional half share in Plot no. 187/A (South Part), admeasuring 150 Sq.yds, or its equivalent 125.41 Sq.mtrs (out of 500 Sq.yds) in Survey No.200 Situated at "Sreepuram Colony" in Saheb Nagar Kalan Village, Hayathnagar Revenue Mandal, Ranga Reddy District, under Ward No.5, Block No.8 of GHMC Limits, Hayathnagar Circle, under registration Sub-District Vanasthalipuram disposal of the Writ Petition and pass, Pending disposal of WP 22492 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of ESLAVATH RAJU Advocate for the Petitioner and GP FOR STAMPS AND REGISTRATION for Respondent Nos.1 to 5 and the Court made the following.

ORDER

Smt S.Sravanthi, learned Assistant Government Pleader for Stamps and Registration takes notice on behalf of the respondents.

The grievance of the petitioners is that *vide* refusal order dated 04.07.2025, the respondent No.5-Sub Registrar, Vanasthalipuram, Ranga Reddy District, has refused to receive, register and release the subject document presented by the petitioners, basing on the letter dated 20.02.2009 addressed by the District Collector, Ranga Reddy District.

Having regard to the fact that there is no notification issued under Section 22-A of the Registration Act, 1908, including the subject land of the petitioners in the list of prohibited properties and as the Registering Authority cannot refuse to register the subject document presented by the petitioners on the basis of the letter dated 20.02.2009 addressed by the District Collector, Ranga Reddy District, there shall be interim direction to the Registering Authority to receive, register and release the subject document presented by the petitioners, subject to the petitioners complying with the provisions of the Registration Act, 1908 and the Indian Stamp Act, 1899.

However, it is made clear that registration of the document shall be subject to the final result of the present writ petition. Such registration is a provisional one and mere registration of the subject document does not confer title to the petitioners in respect of the subject property. It is made clear

that the petitioners shall not claim any equities in case any adverse orders are passed against the petitioners.

Registry shall make an endorsement on the writ petition to the effect that the same shall not be permitted to be withdrawn.

Post this matter along with W.P.No.654 of 2025.
