WHEREAS the Petitioner above named through his Advocate SRI GODA SIVA presented this Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a direction, order or writ more particularly one in the nature of Certiorari a. Calling for all the relevant and connected records relating to the award dated 7.6.2019 passed in I.D. No. 37 of 2015 on the file of the Learned Labour Court - II at Hyderabad as published in G.O. Rt. No. 275 Labour Employment Training and Factories (Labour) Department dated 18.6.2019 and quash or set aside the same in so far as the decision and directions regarding Point No. 2 i.e. the relief to which the Petitioner was entitled as being arbitrary, illegal and unsustainable, b. Consequently, direct that the Petitioner be reinstated into the service of the Respondent Company and that he is entitled to all the consequential benefits including monetary and other service benefits that would flow from grant of the relief at a. above and direct the Respondent Company to release the same together with interest at prevailing Bank rate for fixed deposits on and from the date on which the amount became due and payable till the actual payment;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI GODA SIVA Advocate for the Petitioner, directed issue of notice to the Respondent herein to show cause as to why this WRIT PETITION should not be admitted.
