WHEREAS the Petitioners above named through their Advocate Sri SRICHARAN TELAPROLU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction. one more particularly in the nature of Writ of Mandamus declaring the inaction of the Respondents in disbursing/releasing the outstanding due amount of Rs 6, 67,77,000/- payable to the Petitioner Institution, towards 'reimbursement of tuition fee' for the Academic years 2021-22 to 2024-25 as illegal, arbitrary and in violation of

Articles 14 and 19(1)(g) of the Constitution of India and consequently direct the Respondents to forthwith make payment of the due amount of Rs. 6,67,77,000/- towards reimbursement of tuition fee for the Academic years 2021- 22 to 2024- 25, to the 2nd Petitioner Institution along with interest.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri SRICHARAN TELAPROLU Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

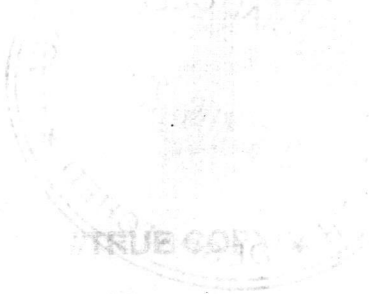
