WHEREAS the Petitioner above named through his Advocate Sri KARUNAKAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the inaction of the Respondents in releasing the Final Bills, EMD and FSD amounts aggregating to Rs. 11,29,922/- (Rupees Eleven Lakhs Twenty-Nine Thousand Nine Hundred and Twenty-Two only), payable to the Petitioner for the FDR works executed under Agreement Nos. 432/2013-14, 339/2013-14 and 132/2013-14 of the Manuguru Irrigation Division, Bhadradri Kothagudem District, inspite of the repeated written representations dt.10-5-2019, 18-3-2024 and 20-4-2026, followed by personal visits, as illegal, arbitrary and violative of Articles 14, 21 and 300-A of the Constitution of India and consequently direct the respondents to forthwith release the above mentioned bills to the petitioner.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Karunakar Reddy, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
