SANJEEV KUMAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction more particularly one in the nature of Writ of Mandamus to declare the inaction of the respondent No.4 herein in not considering the petitioner representation on 20-06-2026 and taking action against the illegal and unauthorized

construction raised by respondent No.7 in Plot No.268, (MIG-268) divided into two parts i.e. 220 and 36.33 Sq.yards don't have road approach towards petitioner plot. Situated at Mayuri Nagar, Miyapur Under GHMC limits Serlingampally Mandal, Ranga Reddy District, as discriminatory, illegal arbitrary and contrary to violation of Article 14,19, 21 of constitution of India and consequently direct the Respondent No.4 authorities herein to demolish the illegal construction being carried out by respondent No.7 in above said premises.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI S.R. SANJEEV KUMAR Advocate for the Petitioner and SRI G. MADHUSUDHAN REDDY, Standing Counsel for the Respondents no. 2 to 6 directed issue of notice to the Respondent Nos. 7 and 8 herein to show cause as to why this WRIT PETITION should not be admitted.

There shall be interim direction to respondent No.3 to stop the unauthorized construction, if any, made by respondent No.7 in Plot No.268 (MIG-268) situated at
