Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents not to alter the nature of the layout in Sy.No.321 of Dommarapochampalli Village, Dundigal - Gandimaisamma Mandal, Medchal District (previously Quthbullapur Mandal, Rangareddy District), pending disposal of WP No. 23876 of 2019, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following.(The receipt of this order will be deemed to be the receipt of notice in the case).

**ORDER:**

The allegation of the petitioner is that Respondents 4 and 5, who claim to be the owners/beneficial owners of the entire block, are in the process of obliterating 30' road and proposing to make construction closing the said road shown in the lay out. Individual LRS has been granted based on the lay out plan under which the respective parties came to purchase. In the circumstances, if the lay out is obliterated, there would be no meaning in granting LRS, as under the scheme, the lay out has been developed without permission, however, conforming to the norms as prescribed by the respective authorities.

In those circumstances, there shall be interim direction as prayed for.
