ORDER

On the other hand, learned Assistant Government Pleader for Land Acquisition did not dispute the interim order dated 24.09.2025 as passed in W.P.No.29340 of 2025.

In view of the above submissions made by both the parties, there shall be an interim direction to the respondents not to dispossess the petitioner from the subject property, pending further orders of this Court.
