Pending further orders, there shall be an interim direction to the respondent authorities not to pay the compensation amount to the respondent Nos.5 to 9 in respect of the petitioners' land to an extent of Ac.1.20 guntas in Survey No.140, Ac.0.02 guntas in Survey No.74/0/1/1, Ac.0.0480 guntas in Survey No.74/J/1/1 and Ac.0.10 guntas in Survey No.140 situated at Nakkalapalli Revenue Village Shivar, Khila Warangal Mandal, Warangal District in pursuance of the notice *vide* Rc.No.B/1590/2024 dated 11.03.2025.
