Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of Respondent No.3 in interfering in civil disputes between the petitioner and Respondent No.4 and life and personal liberty of the petitioner and threatening the petitioner to settle the disputes with the Respondent No.4 as being illegal, arbitrary, discriminatory and violative of Articles 14, 19 and 21 of the Constitution of India and consequently direct the Respondent No. 3 not to interfere in civil disputes between the petitioner and Respondent No.4 and life and liberty of the petitioner without following due process of law.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent No.3 not to interfere in civil disputes between the petitioner and Respondent No.4 and life and liberty of the petitioner without following the due process of law, pending disposal of WP No 21727 of 2026, on the file of the High Court.
