CRL.M.P.No.1003 of 2018 in CRL.M.P.No.394 of 2010 in M.C.No.5 of 2000 by the learned Judicial First Class Magistrate at Parkal.

Heard. Perused the record.

Learned counsel for the petitioner submitted that the learned trial Court passed the impugned order directing withholding of the petitioner's salary without leaving any amount for his personal use, which is in violation of Section 60 of the Code of Civil Procedure and contrary to law.

Having regard to the facts and circumstances of the case and submissions made by the learned counsel for the petitioner, pending further orders, there shall be stay of operation of the Order dated 18.07.2024 passed in CRL.M.P.No.321 of 2023 in CRL.M.P.No.1003 of 2018 in CRL.M.P.No.394 of 2010 in M.C.No.5 of 2000 by the learned Judicial First Class Magistrate at Parkal.
