Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order, direction or writ one in the nature of writ of mandamus directing the respondents 1 to 3 to provide police aid for implementing the permanent injunction order passed in O.S.No.659 of 2010 dt. 22-03-2018, on the file of the Court of the I Additional Senior Civil Judge, Warangal and confirmed by this Court in I.A.No.1 of 2018 pending A.S.No.123b of 2018, dt.30-10-2018 and consequently direct the 4th respondent not to interfere with the agricultural operations of the petitioner to an extent of Ac. 5-01 gts., of agricultural dry land in Sy.No. 454 in Bandimetta Shivar, Munipally Village, Chinthagutta Grampanchayat, Hasanparty Mandal of Warangal District.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents 1 to 3 to provide police aid for implementing the permanent injunction order passed in O.S.No.65q of 2010 dt. 22-03-2018, on the file
