Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate 'Writ, order or direction more particularly one in the nature of Writ Mandamus declaring the action of the respondents is not providing electricity meter connection to the petitioner's shops despite receipt of Demand Drafts and applications as illegal. Arbitrary and unconstitutional and consequently direct the respondents to provide electricity service connections to the petitioner's shops forthwith.
