Nagar Circle-4, Hyderabad is bad arbitrary, illegal by setting aside the letter No.B/662/2025 dt.28/3/2025 of the 2nd respondent herein and consequently direct the respondents for laying of the road on the said passage Champapet to Raghavendra nagar in Ward No.17, Champapet, GHMC, L.B. Nagar Cite-4, Hyderabad .
