WHEREAS the Petitioners above named through their Advocate SRI P K SATYANARAYANA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ or order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not taking any action on illegal unauthorized constructions without any legal documents without any building permission being construction carrying by

the respondents No. 7 and 8 over the petitioner's property house bearing No. 1-143/1/A admeasuring 35166 Sq.yards. situated at Gandhinagar Kapra Village and Municipality Kapra Mandal, Medchal-Malkajgiri District as per the Gift Settlement Deed dated, 11-05-1995 as being arbitrary illegal perverse and void being in derogation of Articles 14, 19 and 300-A of the Constitution of India besides in violation of Telangana Municipalities Act 2019 and Rules there under and consequently direct the Respondents to initiate forthwith action on the representations dt. 27-04-2026, 30-04-2026, 19-06-2026, 25-06-2026 of the petitioner to stop the further constructions and to demolish the illegal and unauthorized constructions carrying by the respondents No. 7 and 8 over the petitioner's property house bearing No. 1-143/1/A admeasuring 351.66 Sq.yards situated at Gandhinagar Kapra Village and Municipality Kapra Mandal, Medchal-Malkajgiri District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. F K SATYANARAYANA Advocate for the Petitioners, directed issue of notice to the Respondent Nos. 7 & 8, herein to show cause as to why this WRIT PETITION should not be admitted.

ORDER

There shall be interim direction to respondent No.4 - the Deputy Commissioner, Kapra Circle - 1, Medchal-Malkajgiri Municipal Corporation, to

stop unauthorised construction, if any, made by respondent Nos.7 and 8 in the property bearing No.1-143/1/A, admeasuring 351.66 square yards, situated at Gandhinagar, Kapra Village and Municipality, Kapra Mandal, Meechal-Malkajgiri District, without any sanctioned plan and report compliance to this Court by the next date of hearing.

Issue notice to respondent Nos.7 and 8.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.7 and 8 under speed post with acknowledgement due and file proof of service by the next date of hearing.
