WHEREAS the Petitioner above named through his Advocate SRI S V RAMANA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of 2nd respondent in raising demand to an amount of Rs.95,75,781/- alleged to be dues in respect of the Power Supply Connection bearing No.SGR 422, by issuing in Lr. No.SE/OP/SGR/SAO/AAO/JAO/HT/ D.No. 244/ 2023, dated 19-06-2023 thereby sought to be recovered from the petitioners service connection bearing SC.No.SGR.1831 situated at Plot No.19/A, Sy.No. 181/1 to 15, Khazipally Village, Jinnaram, Sangareddy at as wholly illegal, untenable, unjust and contrary to the Provisions of Electricity Act,2003 as well the Regulations of Supply Code, General Terms of Conditions of supply and the T.S.Revenue Recovery Act,1864 as such if any such dues alleged to be arrears are hopelessly barred by provisions of Limitation Act,1963 and consequently direct the respondents refraining from disconnection of supply to the service connection to the petitioner aforementioned service connection.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri S V RAMANA Advocate for the Petitioner and SRI N. SREEDHAR REDDY, Standing Counsel for respondent Nos. 1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents refraining from disconnection of power supply to the petitioner service connection bearing No.SGR 1831 situated at Plot No.19/A, Sy.No.180/ 1 to 15, Khazipally Village, Jinnaram, Sanga Reddy District and District, pending disposal of WP No. 23193 of 2025, on the file of the High Court.

IA NO: 2 OF 2025

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to permit the petitioner consider the above payment scheduled thereby refrain further disconnection of power supply to the petitioner service connection bearing No.SGR 1831 situated at Plot No.19/A, Sy No.180/1 to 15, Khazipally Village, Jinnaram, Sanga Reddy District and District, pending disposal of WP No. 23193 of 2025, on the file of the High Court.

ORDER**

Notice before Admission.

Sri.N.Sreedhar Reddy, learned Standing Counsel for TSSPDCL takes notice for respondent Nos.1 to 4.

List on 16.09.2025.

Learned counsel for petitioner Sri S.V.Ramana submits that petitioner will pay the amount demanded in six equal monthly instalments at Rs.5,00,000/- (Rupees five lakhs only) each, as detailed in the affidavit filed in support of the Application, excluding Rs.17,50,000/- already paid on 28.08.2025.

Learned Standing Counsel vehemently opposed for the said proposal.

In view of the same, this Court is not inclined to grant six installments, as requested. However, to test the *bona fides* of petitioner, on the assurance given by learned counsel, it is directed that petitioner shall deposit Rs.10,00,000/- (Rupees ten lakhs only) within one week from today and future installments will be decided by this Court on the next date of hearing.

Subject to the above, there shall be interim direction to respondents to forthwith restore power supply to petitioner's Service Connection bearing No. SGR 1831 situated at Plot No. 19/A, Survey No. 180/1 to 15, Khazipally Villa Jinnaram, Sanga Reddy District.
