Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to A)Issue an Order or Direction, more particularly one in the nature of Writ of Mandamus directing the Respondent No. 2 to 5 to take necessary action to prevent the said land of 28 Guntas from being misused as grave yard by the miscreants, B)DIRECT the Respondents to NOT TO ALLOW THE SAID LAND TO BE USED AS GRAVE YARD BY ANY ONE, and also TO ISSUE NECESSARY PROCEEDINGS, pending disposal of the writ petition.

I.A. NO: 2 OF 2025:

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to issue orders of stay on the activities of the miscreants in the said land, pending disposal of WP No 23396 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the AFFIDAVIT filed in support thereof and upon hearing the arguments of Sri T. Sasi Kumar Advocate for the Petitioners, GP FOR REVENUE for the Respondents, the Court made the following.

ORDER:

Heard learned counsel for the petitioners and learned Assistant Government Pleader for Revenue.

As seen from the written instructions, a report bearing Lr.No.B/342/2025 dated 23.06.2025 was submitted by the Tahsildar, Ghatkesar Mandal, to the Collector, Medchal-Malkajgiri District, wherein it is stated that arch in the name of Vaikunta Dhamam (grave yard) was constructed without any permission on the disputed land, which is classified as patta. An extent of Ac.0.25 guntas is covered without fencing and compound wall beside the existing NALA/Vaagu. The locals are requesting them to allot the said land for park as it is situated within the residential area and some others are requesting to conduct funeral rites in the existing grave yard in Sy.No.46/1.

As it is stated that no permission was taken for constructing the arch in the name of Vaikunta Dhamam, there shall be interim direction to the respondents No.3 to 5 not to allow the land admeasuring Ac.0.28 guntas in Sy.Nos.71 and 75, Ismailkhanguda Village, Ghatkesar Mandal, to be used as grave yard, until further orders.
