Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or writs, order or orders, direction or directions, more particularly one in the nature of writ of Mandamus, declaring the action of the Respondents in issuing notice vide No.F3/14/2026, dated 08.07.2026 directing the petitioner to present at Sri Rajarajeshwara Industries situated at Singaram Village, Yellaredyypet Mandal, Rajanna Sircilla District, mill premises on 10.07.2026 to 11.07.2026 to conduct panchanama and attempting to seize the petitioner rice mill along with paddy as being arbitrary, illegal, high handed, unjust and in violation of principles of natural justice and further violative of Art-14, 19(1)(g), 21 and 300-A of the constitution of India and against to the provisions of law established under Essential Commodities

Act and consequentially suspend the operation of impugned notice vide No.F3/ 14/2026, dated 08.07.2026.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to stay all further proceedings pursuant to notice vide No.F3/ 14/2026, dated 08.07.2026 including seizure of the petitioner rice mill M/s.
