Mr. K. Karuna Sagar, learned counsel for the petitioners, submitted that the matter before the trial Court has not ripened for trial and is at the stage of appearance of the parties.

The presence of petitioner Nos.2 to 8/accused Nos.2 to 8 in S.C.No.56 of 2025 on the file of the I Additional Sessions Judge, Karimnagar, is dispensed with, subject to the condition that petitioner Nos.2 to 8/accused Nos.2 to 8 shall be represented through their counsel on each and every date of hearing. If the presence of petitioner Nos.2 to 8/accused Nos.2 to 8 is required, they shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
