WHEREAS the Petitioner above named through his Advocate SRI PODILA HARI PRASAD presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus declaring the action of the Respondents No.2 and 3 not taking action against illegal/unauthorized constructions including not acting upon the Petitioner's complaint dated 15/06/2026 lodged for cancellation of permissions of constructions if any granted in the land of the Petitioner in favour of the unofficial Respondents herein which were obtained by them by suppressing material fact of title dispute pending for adjudication in O.S. No.96/2021 on the file of Learned Principal Senior Civil Judge at Warangal, further the action of the Respondents No. 4 to 6 not taking action against illegal/unauthorised drilling of five boreholes by unofficial Respondents in the land belongs to Petitioner, further the action of the Respondents No. 7 to 10 not taking action against all the unofficial Respondents with aid of illegal elements. Gundas trespassed into the land of the Petitioner by force attacked and injured family of the Petitioner with sticks and rods and damaged the land by drilling five boreholes illegally at Eastern side of land belongs to the Petitioner in Survey No.870/A 2 admeasuring Acres 2.20 Guntas situated at Waddepally revenue Village, Hanamkonda Mandal, Warangal District (Old), Hanamkonda District (New) and not come to rescue of family of the Petitioner including not even acted upon the complaint dated 10/07/2026 lodged by the Petitioner and not received a complaint dated 12/07/2026 which was tried to lodged by the victim to punish the culprits who caused injury to one of the family member of the Petitioner, is illegal, arbitrary and in violation of fundamental rights guaranteed under Art. 14, 21 and 300-A of Constitution of India.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI PODILA HARI PRASAD Advocate for the Petitioner, directed issue of notice to the Respondents No. 11 to 27 herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No.7 to 10 take action against all the unofficial Respondents who with aid of illegal elements, Gundas trespassed into the land of the Petitioner by force attacked and injured family of the petitioner with sticks and rods and damaged the land by drilling five boreholes illegally at Eastern side of land belongs to the Petitioner in Survey No.870/A/2 admeasuring Acres 2.20 Guntas situated at Waddepally revenue Village, Hanamkonda Mandal, Warangal District (Old), Hanamkonda District (New) and consequently give protection to family of the Petitioner including act upon the complaint dated 10-07-2026 lodged by the petitioner apart from receiving a complaint dated 12-07-2026 which was tried to lodged by the victim to punish the culprits who caused injury to one of the family member of the Petitioner, pending disposal of W.P. No.22565 of 2026, on the file of the High Court.

I.A. NO: 3 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct Respondent No. 4 to 6 take action against illegal and unauthorised drilling of five boreholes by unofficial Respondents in the eastern side of land belongs to Petitioner in Survey No.870/A/2 admeasuring Acres 2.20 Guntas situated at Waddepally revenue Village, Hanamakonda Mandal, Warangal District (Old), Hanamakonda District (New) in pending consideration of main Writ Petition, Pending disposal of WP No 22565 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Issue notice to respondent Nos.11 to 27.

Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.11 to 27 and file proof of service by the next date of hearing.

Learned Standing Counsel for the Greater Warangal Municipal Corporation appearing for respondent Nos.2 and 3 submitted that on complaint of the petitioner, site of the unofficial respondents was inspected; it was found that the compound wall has been unauthorisedly constructed by them in the subject property, and necessary action has to be taken. It is further stated that as of now, there is no construction activity made by unofficial respondents.

Respondent No.6 - Tahsildar, Hanamkonda, is directed not to permit drilling of bore-well in the subject property, unless permission is obtained by respondent Nos.11 to 27. Respondent No.3 - Deputy Commissioner, Kazipet, Circle - II, Greater Warangal Municipal Corporation, is also directed to ensure that no further unauthorized construction is undertaken in the subject property.
