WHEREAS the Petitioner above named through his Advocate SRI POLE VISHNU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus to declare the action of the respondent No.6 herein in intentionally mentioning the Section of Law as 194 of BNS in relation to FIR No. 53/2025 dt. 19-4-2025 when the complaint given by the petitioner clearly attracts Section 107 of BNS, inspite of the personal visits, as being illegal, arbitrary, unjust and unconstitutional and consequently direct the respondent Nos. 2 to 5 herein to take action against the 6th respondent for his illegal acts and to entrust the investigation into FIR No. 53/2025 to some other investigating agency or CBCID, for proper investigation.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri POLE VISHNU Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
