Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly writ of mandamus declaring the inaction of the respondents in executing the agreement in favour of the Petitioner Firm, pursuant to the tender notice dated 20-09-2019 in which the petitioner declared to be successful bidder and constrained to allot in favour of the 3rd parties who had not submitted the tenders as being illegal, arbitrary and unconstitutional, consequently direct the respondents to issue tenders in favour of the Petitioner Firm being successful bidder.

IA NO: 1 OF 2019

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to issue work order in favour of the 3rd parties other than the Petitioner Firm as the petitioner being the lowest bidder pursuant to the tender notice vide No.F/1152/2019-20, dated 20-09-2019, pending disposal of the WP.No.25168 of 2019, on the file of the High Court.

IA NO: 2 OF 2019

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to issue work order in favour of the Petitioner Firm pursuant to the tender notice vide No.F/1152/2019-20, dated 20-09-2019, pending disposal of the WP.No.25168 of 2019, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.K.HEMALATHA Advocate for the Petitioner and GP for Municipal Administration (TG) for Respondent No.1 and Sri.N.Praveen Kumar standing counsel for respondents 2&3 and GP for Revenue (TG) for Respondents 4&5, the Court made the following.

ORDER

Heard the learned counsel for the petitioner.

Learned Standing Counsel for respondents 2 and 3 submits that tender of the petitioner was rejected on 26.10.2019, and he seeks time for further instructions.

It is to be seen that matter underwent two adjournments for instructions. When the tender of the petitioner was rejected on 26.10.2019, it is not known why the learned Standing Counsel has not produced any proceedings in this regard.

Post on 25.11.2019 in the motion list.

Till then, all further proceedings in pursuance of impugned tender notification shall remain stayed.
