WHEREAS the Petitioner above named through her Advocate Sri B SUDHAKAR REDDY AND NEERAJA REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issued order or orders, Writ or writ more particularly a Writ of Mandamus declaring the action of the Respondent No.2 in publishing final selection list vide proceedings No.A2/240/2015, dt.7-3-2020 by including the name of the 3rd respondent, when her application was summarily rejected, as per Clause 2(b) in Annexure issued in recruitment notification, to the post of Junior Assistant under SC Women Category for SC/ST Backlog-2018, Adilabad District, by receiving the consolidated memorandum of marks on 5-2-2020, under the guise of receiving objections in pursuance of the proceedings No.A2/240/2015, dt.1-2-2020, when 4-7-2018 was the cut off date, as violative of Mandatory Clause 2(d) & 2(b) of Annexure-I of the Notification dt.20-06-2018 as illegal, arbitrary, and against all tenets of Law and Principles of Natural Justice, and consequentially to set aside the Provisional final section list of junior assistants undr SC(G) category, proceedings No.A2/240/2015, dt.7-3-2020, and confirm the provisional selection list published in proceedings No.A2/240/2015, dt.1-2-2020, and consequently direct the respondent no.2 to issue appointment/posting orders to the petitioner, in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri B SUDHAKAR REDDY AND NEERAJA REDDY Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
