ORDER

Having regard to the earlier orders of this Court in W.P.No.31141 of 2018 wherein, this Court directed maintenance of status quo, in so far as land to an extent of Ac.6-10 guntas in Sy.No.215 of Mogaligadda Village, Farooqnagar Mandal, Ranga Reddy District, the Tahsildar, could not have undertaken mutation exercise.

Therefore, the impugned proceedings are suspended to the extent of mutation of name of M.Laxman Rao on land to an extent of Ac.1-26 guntas in

Sy.No.215/UU of Mogaligadda Village, Farooqnagar Mandal, Ranga Reddy District.
