WHEREAS the Petitioner above named through his Advocate Sri R A Achuthanand presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or writs order or direction more in the nature of

a Writ of mandamus declaring the action on the part of the respondents No.3 in particular in handing over the Keys of the tenanted premises bearing M.No. 5-4-7,5-4-7/1, 5-4-7/2 and 5-4-7/3, "Mahaprabhu House" Situated at Jawaharlal Nehru Road, Near Abids, Hyderabad (Subject Tenanted Property) without removing the seal as per direction of the Hon'ble High court in W.P.No.9780 of 2026, dated 01-07-2026 and unlawfully handing the keys to Respondent No. 7 herein (though not a party to the writ petition) who represented the 7th respondent Trust instead of removing the seal and handing over the keys if locked by GHMC; to the petitioner whose subject tenanted property was unlawfully sealed despite the Distress Warrant issued by the Respondent No.3 against the petitioner having been suspended by this Hon'ble Court by order dated 26-08-2025 by playing Fraud and collusion thereby violating the orders made in W.P.No. 9780 of 2026 dt.01-07-2026 while facilitating the respondent no. 6 and 7 to restrain free access to the petitioner to its Tenanted Property impacting the right to enjoy property and conduct business resulting in breach of the Constitutional Rights of the petitioner as contained in Art.14, 19, 21 and 300A of the Constitution of India in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. R A ACHUTHANAND, Advocate for the Petitioner, Government Pleader for MA&UD for Respondent No.1, Government Pleader for Home for Respondent No.5 and Sri M. Arun Kumar, Standing Counsel for GHMC for Respondent Nos.2 & 3 directed issue of notice to the Respondent Nos.6 & 7 to show cause as to why this WRIT PETITION should not be admitted.
