: ORDER :

This writ petition is filed to declare the action of the respondent Nos.2 to 5 in interfering with the lawful possession and enjoyment of the petitioners' individual plots in Sy.Nos.837 and 838, Upparapally Village, Shameerpet Mandal, Medchal-Malkajgiri District, without following due process of law, as illegal and arbitrary and for consequential relief.

2. Heard Sri M.Sambasiva Rao, learned counsel for the petitioners and learned Assistant Government Pleader for Revenue.

3. Learned counsel for the petitioners would submit that in the year 1999, the HUDA developed a layout in Sy.Nos.837 and 838 at Upparapally Village, Shameerpet Mandal, Medchal-Malkajgiri District, in an area of Ac.18.00, consisting of 592 plots, by providing all the facilities, vide approved layout in File No.374/MP2/HUDA/96, dated 22.02.1999, and handed over the said layout to the Government; that the respondent

No.3 has issued proceedings No.B1/1736/94, dated 04.01.2003, allotting the said plots in favour of the petitioners and some other third parties; that after allotment each allottee has got 100 Square Yards. While so, the Government has acquired 50% of the layout area for the purpose of formation of Outer Ring Road, due to which the allotment made to the individual in the year 2003 was reduced from 100 square yards to 80 square yards; that a new patta certificates have been issued to the allottees indicating old and new plot numbers in the year 2014. Since then, the petitioners have been in peaceful possession of their respective plots. In October, 2018, however, the respondent authorities came to the subject plots of the petitioners and demolished the structures/houses being raised by the petitioners. Aggrieved by the same, the petitioners once again applied for permission to construct houses, but, received no response from the respondents. Suddenly, on 20.11.2019, the respondent authorities, again, visited the subject plots and demolished the existing structures, stating that the subject plots were required for some other purpose. Aggrieved by the said action of the respondent authorities, present writ petition is filed.

4. Counter affidavit has been filed on behalf of respondent No.4-Tahasildar, stating that the house site pattas were issued to the petitioners in the year 1999 with certain terms and conditions. One such condition was that the allottees were required to construct houses within a period of six to twelve months from the date of allotment. However, in contravention of the said condition, the allottees/petitioners failed to raise

structures until 2014, i.e., after a lapse of 14 years. Therefore, the respondents are entitled to resume the subject plots and re-allot the same. Accordingly, the writ petition is devoid of any merits and the same is liable to be dismissed.

5. Learned counsel for the petitioners would submit that the subject plots were allotted to the petitioners in the year 1999; and that even if there was any violation of the condition to construct houses within stipulated period, no action was taken by the respondent authorities until 2014. He further submitted that in the event of any violation of conditions, the respondent authorities are required to follow the due procedure as prescribed under law. However, the respondent authorities, without issuing any notice and without following the procedure prescribed under law, highhandedly demolished the existing structures/houses in the subject plots and prayed to allow the writ petition..

6. Learned Assistant Government Pleader for Revenue would submit that the subject plots were allotted to the petitioners subject to compliance of conditions specified in the house site pattas, and that the petitioners did not comply with the conditions, specified in the house site pattas. Therefore, the respondents are entitled to resume the subject plots.

7. A perusal of the material placed on record disclose that house site pattas were issued to the petitioners with certain conditions and clause-2 of such conditions stipulate that petitioners shall construct houses within

a period of 6/12 months. In the present case, it is specifically contended by the respondents that the petitioners failed to construct houses within the stipulated period, therefore, the respondents have taken steps to resume the pattas. However, the Respondents neither issued any notice nor followed any procedure before resorting to demolition of houses. The respondents ought to have issued notices to the petitioners before taking steps for demolition of structures, therefore, the action of respondents is in clear violation of principles of natural justice.

8. In the light of the above, the writ petition is disposed of with a direction to respondent authorities not to interfere with the possession and enjoyment of petitioners of the subject plots, except in accordance with law. However, it is made clear that this order will not preclude the Respondents from taking action against the petitioners for violation of the conditions of the house site pattas, strictly in accordance with the procedure prescribed under law. There shall be no order as to costs.

As a sequel thereto, miscellaneous petitions, if any, pending in the writ petition, shall stand closed.

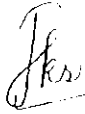

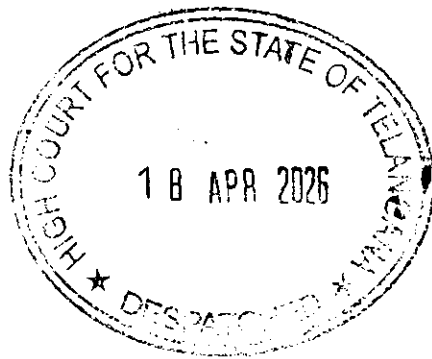
