Interim stay granted earlier is extended till then.

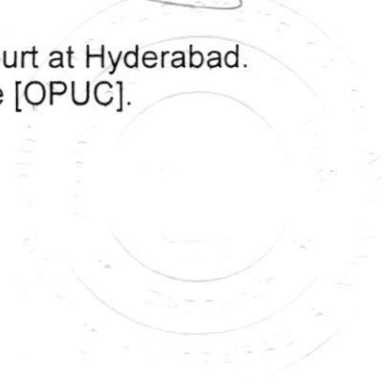
