Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ or order or direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents in unilaterally deleting petitioner's name from revenue records in respect of Sy.No.127 admeasuring total extent of Ac-3.20 guntas situated in Venkiryala Village, Bibi Nagar Mandal, Yadadri-Bhongiri District as being illegal, arbitrary, un- constitutional, violative of principles of natural justice and violative of Article 14, 19 and 300-A of the Constitution of India and contrary to the provisions of The Telangana Rights in Land and Pattadar Pass Books Act, 1971 and the Rules made there under in the interest of justice and consequently to direct the respondents to restore the name of the Petitioner in respect of land admeasuring Ac.3.20 gunts situated in Survey No.127 of Venkiryal Village;

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri P SHASHI KIRAN, Advocate for the Petitioner and ASSISTANT GP FOR REVENUE, for the Respondents, the Court made the following
