WHEREAS the Petitioner above named through his Advocate Ms SRIRAMBHATLA VINEETHA SHARMA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or directions more particularly a Writ in the nature of mandamus declaring the action of the 5th respondent in granting regularization of the unapproved layout vide proceedings No. LRS28042017042641, dated 28.04.2017 and house building permission as wholly

arbitrary illegal and violative of Articles 14, 16 and 21 of the Constitution of India and consequently direct the official respondents not to permit the 7th and 8th respondents not to raise any further construction in respect of the unapproved layout.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Ms SRIRAMBHATLA VINEETHA SHARMA Advocate for the Petitioner and Sri Srinivas Rao P, standing Counsel for the respondent Nos. 2 to 5, directed issue of notice to the Respondent Nos. 6 to 8, herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the official respondents, more particularly that of the respondent Nos.5 and 6 not to allow any encroachment on the public road which is as per the original sanctioned layout and to remove the construction material illegally dumped on the public road creating lot of inconvenience to the residents while passing through the public road and to maintain the subject land as public road till the disposal of the suit in 641 of 2019 before the III Addl. District Judge, Ranga Reddy District at L.B.Nagar which is transferred to I Additional District and Sessions Judge cum Additional Family Court-Special Sessions Judge for Fast Tracking the Case relating to Atrocity Against the Women, Medchal-Malkajgiri District at Kushaiguda and renumbered as O.S. No. 670 of 2022, pending disposal of WP No 26098 of 2026, on the file of the High Court.

ORDER

Issue notice to respondent Nos.6 to 8.

The learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.6 to 8 and to file proof of service in the registry.

The learned Standing Counsel appearing for Respondent Nos.2 to 5 seeks time to get instructions.

The Respondent No.4 is directed not to allow respondent Nos.5 and 6 to raise any unauthorized constructions on public road (Street No.4, HMT Nagar, Nacharam, Hyderabad) and report compliance by the next date of hearing.
