Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to permit the petitioner herein to withdraw the deposited amount by the 1st Respondent/ Insurance Company in pursuant to the interim order dated 15/09/2025 passed in IA No 3 of 2025, pending disposal of MACMA No. 1236 of 2025, on the file of the High Court.

**IA No 3 of 2025:**

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of operation of decree and judgment dated 18-11-2024 in M.N.O.P.No.113 of 2023 on the file of Motor Accident Claims Tribunal-cum-I Additional District Judge, at Kamareddy, pending disposal of MACMA No. 1236 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 15.09.2025 made in I.A.No.3 of 2025 and upon hearing the arguments of Sri HARINATH REDDY SOMA Advocate for the Respondent No. 1 and Sri AKKAM ESHWAR Advocate for the Petitioners.

The Court made the following  
**ORDER**

**This application is filed by the claimants to permit them to withdraw half of the compensation amount deposited by the appellant-Insurance Company in pursuant to the orders passed by this Court on 15.09.2025.**

**This Court by order, dated 15.09.2025 in I.A. No. 3 of 2025 granted stay of operation of the decree dated 18.11.2024 passed in M.V.O.P. No. 113 of 2023 on the file of the Chairman, Motor Accident Claims Tribunal-cum-I Additional District Judge at Kamareddy, on condition of appellant-Insurance Company depositing 50% of the decretal amount together with costs and interest.**

**Now, it is submitted by the learned Standing Counsel for the appellant that the conditional order has already been complied with by depositing 50% of the decretal amount together with costs and interest as directed by this Court.**

**Therefore, the interim stay granted by this Court dated 15.09.2025 is made absolute and the claimants, except minors, are permitted to withdraw the amount already deposited by the appellant-Insurance Company together with costs and interest without furnishing any security.**

**Accordingly, the application stands disposed of.**
