Petition Under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the he Order dated 23-06-2024 in IA.No.457 of 2024 in DVC.No.89 of 2024 passed by the learned II AJCJ-CUM- X Addl. Judicial First Class Magistrate, Ranga Reddy District at Kukatpally, pending disposal of CRP No. 3359 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 19.09.2025 made in IA.No.1 of 2025 and upon hearing the arguments of above mentioned counsel;

The Court made the following;
ORDER:

Both the learned counsel present.

Learned counsel for the petitioner submits that the petitioner has complied with the order of this Court dated 19.09.2025 and requested to reduce the maintenance amount from Rs.50,000/- per month to Rs.25,000/- per month.

Per contra, learned counsel for the respondent Nos.1 and 2 submits that an Interim stay of impugned order dated 23.06.2025 was granted by this Court in I.A.No.1 of 2025 in C.R.P.No.3359 of 2025 subject to the petitioner depositing 50% of the arrears of three months i.e. July, August and September of the year 2025 which comes to Rs.75,000/- and that the petitioner has complied with the said order, and after that nothing has been paid till date.

Having been considered the request of the learned counsel for the petitioner for reduction of maintenance amount from Rs.50,000/- to Rs.25,000/-, this Court directs the petitioner to pay Rs.25,000/- per month from October, 2025 to March, 2026 i.e., 1,50,000/- (Rupees one Lakh Fifty Thousand only) to the respondents within a period of four (04) weeks from the date of receipt of a copy of this order.
