Petition under Section 430(1) of BNSS., praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to extend the interim bail to the petitioner for a period of 15 days i.e., from 10/12/2025 to 25/12/2025 by suspending the sentence in SC.No.329 of 2016 on the file of the Principal Sessions Judge Rajanna Sircilla as petitioner's father was died on 09/12/2025 pending disposal of the CRLA, pending disposal of CRLA No. 902 of 2024, on the file of the High Court.

I.A.No.1 of 2025

Petition under Section 528 of BNSS, praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to grant interim bail to the petitioner for three months from 14/08/2025 to 13/11/2025 as the petitioner's father is suffering from various organs damage ailments and the presence of the petitioner is necessary to attend the medical and financial requirement of his family, pending disposal of CRLA No.902 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 12.09.2025 made in I.A.No.1 of 2025 and the order dated 10.10.2025 made in IA. No. 2 of 2025 and upon hearing the arguments of Sri Venkat Reddy Kodumury, Advocate for the Petitioner/Accused No.1 and of Sri Syed Yasar Mamoon, Additional Public Prosecutor, for the Respondent.

The Court made the following
ORDER:

This application is filed seeking *interim* bail to the petitioner herein - accused No.1 on the ground that his father - accused No.2 in S.C. No.329 of 2016 died on 09.12.2025. According to learned counsel, funeral was over on 09.12.2025 itself.

In the light of the above, we have directed learned Additional Public Prosecutor to get instructions. He has produced written instructions dated 10.12.2025 of the Sub-Inspector of Police, Vemulawada Rural Police Station, wherein he has confirmed the death of the father of the petitioner herein i.e., accused No.2.

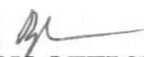
In the light of the above, we are inclined to grant *interim* bail to the petitioner herein - accused No.1 for a period of two (02) weeks i.e., from 10.12.2025 to 24.12.2025.

Therefore, the Superintendent, Central Prison, Cherlapally, Medchal - Malkajgiri District, is directed to release the petitioner herein - appellant - accused No.1 today itself i.e., 10.12.2025 by 5.00 P.M. During the said period of *interim* bail, the petitioner shall not indulge in any criminal acts. On completion of the said period, the petitioner herein shall surrender before the Superintendent, Central Prison, Cherlapally, Medchal - Malkajgiri District, on 24.12.2025 by 5.00 P.M.

This application is accordingly ordered.
