Petition under Section 151 CPC praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to stay the operation of Judgment and Decree dated 28.06.2025 in O.P No 715 of 2020, passed by the I Additional Family Court-Cum-XIV Additional Metropolitan Sessions, at Hyderabad, Pending disposal of FCA No. 149 of 2025, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

After hearing learned counsel appearing for the appellant, who was the respondent in O.P.No.715 of 2020 filed by the respondents herein before the Trial Court for maintenance. The impugned order dated 28.06.2025 is modified

to the extent of directing the appellant to pay Rs.50,000/- per month to the respondents until further orders.

Learned counsel appearing for the appellant submits that the appellant has been paying Rs.40,000/- per month to the respondents from 2020 (during the course of the said O.P.) and arrears with regard to the differential amount were also paid by the appellant to the respondents from 28.06.2025 till date.

Arrears, if any shall be paid by 16.10.2025. The appellant shall keep a copy of Memo of the monthly amount being paid to the respondents, till the Appeal is heard.

The respondents shall be at liberty to file counter to I.A.Nos.2 and 3 of 2025 in the meantime.
